

The Alabama Veterinary Practice Owners Association was born out of necessity last year when the ALVMA refused to take a stand with the ASBVME to oppose spay/neuter clinics offering full service while enjoying tax exempt status. The ALVPOA sided with the ASBVME and thwarted changes to the practice act. The Alabama Veterinary Medical Association has come under fire recently concerning leadership issues. In fact several constituent associations have recommended changing the Executive Director position from Franz Management. You as a practitioner owe it to your profession to become informed and express your wishes. Seek out a practitioner that you trust to be informed and honest to answer your questions. It is imperative that you veterinarians on the front line and behind the exam tables everyday have input in the way these issues are resolved.

It has never been more important than now for these three groups to agree on what is best for our profession. Let your voice be heard!

## *CONTINUING VETERINARY EDUCATION AND YOU*

To paraphrase Mark Twain, misinformation can travel halfway around the world while the truth is putting on its shoes. As Chairman of the Continuing Education (CE) Committee I have been questioned by concerned veterinarians within Alabama regarding CE. All CE has to be approved by the Alabama State Board of Veterinary Medical Examiners (ASBVME). That sounds fairly straight forward and not much different from the accounting board and public accountants. But suddenly, as Chairman of the committee responsible for approval of the courses available, I became a little uneasy. To be sure, I would readily approve an orthopedic course presented by Dr. Robert Horne or a colic lecture by Dr. Tom Vaughan. But what about a meeting on the subject of **Veterinary Marijuana** (see June 01, 2013 AVMA News Express)?

Since no individual (especially me) or committee can know the quality/content of every meeting in North America, much less if it would qualify for legitimate CE, help is needed. Remember that the BOARD has a **legal and professional duty** to protect the license of the Alabama veterinarian as well as protecting the public and their animals. Our BOARD is a member of the AMERICAN ASSOCIATION OF VETERINARY STATE BOARDS ([www.aavsb.org](http://www.aavsb.org)). Their REGISTRY OF APPROVED CONTINUING EDUCATION (**RACE**) serves as a **recognized and respected clearinghouse** for the review and approval of continuing education providers/speakers and their programs. Remember, veterinary CE is **not** standardized among all state veterinary boards.

RACE approved CE consists of educational activities that serve to maintain, develop, or increase the knowledge, skills, and professional performance and relationships that a veterinary professional uses to provide services for patients, the public or the profession.

If a faculty member from Oregon State University is presenting a lecture on the zebra fish (widely used in research) at an **event that is not RACE** approved, you can relax because he/she is more than likely a diplomat of the American College of Laboratory Animal Medicine. The ASBVME will gladly approve this meeting for the appropriate CE hours for you.

If you have followed current events facing our Alabama profession you realize how quickly misunderstandings and ill will can occur. Look at the national association and their questions and concerns on holistic medicine or animal welfare/animal rights. The ASBVME is being proactive in anticipation of potential problems regarding CE. “The future is not what it used to be,” to quote Yogi Berra.

I hope this brief explanation of our CE requirements eliminates any worry you may have about any upcoming meeting you may wish to attend for CE hours. If you have specific questions about a course, please submit them to the CE Committee in writing so that they may be properly addressed.

## 2014 License Renewals

This is just a friendly reminder that starting in October, you will be able to go to our website, [www.ASBVME.alabama.gov](http://www.ASBVME.alabama.gov), and renew your DVM license or your LVT license, just like you did last year.

We would like to remind all of our new graduates that after December 31st of each year your license will be considered late, and you will incur a late penalty. This Board by law can not waive any late fees, no matter the circumstances.

Also you need to make sure that you have your 20 hours of continuing education if you are a veterinarian, and 8 hours of continuing education if your are a licensed veterinary technician, before December 31st.

If you do not have access to a computer or you are unable to pay online, you may contact the ASBVME Office and we will mail to you a hard copy of your license renewal and continuing education form. You need to contact this office by December 1st, 2013 in order to insure that we may receive your renewal by December 31st, 2013.
